A. EXPLANATORY NOTES TO THE INTERIM FINANCIAL STATEMENTS - MFRS 134

A1 Basis of Preparation and Accounting Policies

The interim financial statements are unaudited and have been prepared in accordance with the requirements as set out in Malaysian Financial Reporting Standards ('MFRS') No. 134: Interim Financial Reporting and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

B1 <u>Review of Performance</u>

The Group registered a revenue of RM17.1 million for the current quarter and period to date, which represents a 6.5% increase over the RM16.0 million for the preceding year corresponding quarter and period to date. Profit before taxation of RM1.28 million for the current quarter and period to date is 13.2% higher as compared to RM1.13 million for the preceding year corresponding quarter and period to date. The increase in revenue for the current quarter and period to date was mainly attributable to higher sales volume and higher selling prices for the Group's brick products. Despite the higher selling prices, margin was in fact lower as the rise in costs of production following the hike in electricity tariff from 1 January 2014, was only partially passed through to the customers.

The improved results was also partly attributable to the lower finance costs as a result of the partial redemption of RCSLS.

B2 <u>Material Change in Profit Before Taxation for the Current Quarter compared to the</u> <u>Immediate Preceding Quarter</u>

There was no material change in profit before taxation of RM1.3 million for the current quarter as compared to RM1.2 million for the immediate preceding quarter under review.

B3 <u>Commentary on Prospects</u>

As reported by the Bank Negara Malaysia, Malaysian economy chalked up a 6.2% expansion in gross domestic product ("GDP") in the first quarter of this year.

With the brighter outlook of the Malaysian economy, the management anticipates that the construction and residential sub-sector would continue to hold out despite the Government's property price cooling measures and the domestic cost push inflation worry due to the government's effort in reducing the federal budget deficit by cutting subsidies.

However, rising operation and production costs will continue to be of concern to the management. The hike in electricity tariff, rising fuel prices and transportation costs will continue to put pricing pressure and pose challenges to the Group's performance.

Nevertheless, The Management will continue its effort in improving cost efficiency and optimizing productivity, and the Group will strive to achieve satisfactory financial results for the year 2014.
